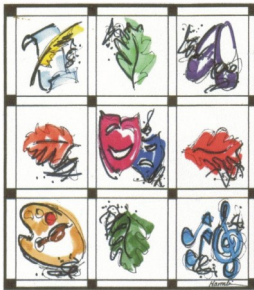

# Beyond Reason

A JURIED MIXED MEDIA EXHIBIT

**September 1—November 30, 2018**

**Beyond Reason**, a juried exhibit, is open to all artists 18 years of age or older. All two-dimensional media is eligible. No types of photography or three-dimensional art can be entered in the Beyond Reason event. (Photography and 3-D art can be entered in the upcoming photograph/3-D juried exhibit planned to begin April, 2019.)

All work must be **original** creations of the artist (no prints can be entered) and must have been completed within the last three years. **Do not submit work which has been previously shown in other Davie County Arts Council exhibits.** There should be no reproductions or classroom work, two-dimensional work must be no larger than forty-eight inches in either dimension. The Davie County Arts Council reserves the right to decline any work deemed unsuitable for the Brock Art Gallery.

#### **ENTRY FEE**

Each artist is allowed to enter (2) works of art for \$15.00.

#### **AWARDS**

**First Place \$250**

**Second Place \$150**

**Third Place \$100**

**Honorable Mentions -At the Juror's Discretion-**

#### **ART WORK SALES OPTIONAL**

The ArtWorks Committee asks that **20%** of any art work sold be donated back to the Davie County Arts Council (this would be a tax-deductible donation to future art projects.) Transactions for purchase will be between the buyer and the artist and would work on the honor system. If the patron contacts the arts council we will provide your contact information to any interested parties. If your art work is not for sale please state that on your registration form as NFS.

## **DAVIE COUNTY ARTS**

### **REGISTRATION AND DELIVERY**

Registration forms must be completed for each entry of art work, or the art work will not be accepted. Art work may be delivered at two different dates and times as follows:

**Wednesday, August 27, 2018 1:00 PM until 4:00 PM**

**Thursday, August 28, 2018 1:00 PM until 4:00 PM**

Art work must be registered during these dates and times. Do not drop-off art work without registering it with an arts council representative.

### **SPECIFICATIONS FOR ART WORK ENTRY**

Art work must be ready to hang with a wire. ArtWorks' members nor arts council's staff will be responsible for providing the parts or labor to prepare the frames of art work to be hung. No saw tooth hangers. (Davie County Arts Council will not be responsible for re-attaching screw eyes or hangers to art work.)

Entry forms must include full disclosure of the medium used to accomplish the art.

Fill out the entry form provided herein for each piece entered. The information you give will be the information shown on the exhibit label. The label reflects upon the artist, please print legibly so that your name and other information will be spelled correctly for the exhibit.

### **PICK-UP OF ART WORK**

All art work accepted must remain—**WITHOUT EXCEPTION**—until the close of the exhibit date, and may be picked up on the following date and times— **Gallery is only open Monday-Friday from 12:00 until 5:00 p.m. or during performances.**

**THURSDAY, NOVEMBER 29, 2018 OR**

**FRIDAY, NOVEMBER 30, 2018**

**ONLY BETWEEN THE HOURS OF 1:00 P.M. UNTIL 4:00 P.M.**

Artists must check their art work out with arts council staff. Any art work not picked-up within thirty days after the close of the exhibit becomes the property of the Davie County Arts Council.

Winners will be notified by their choice of phone call or email. All winners will be posted on the Davie County Arts Council’s Facebook site. Artists are encouraged to “share” the site for the Beyond Reason Exhibit and all other arts activities being shown on this site.
